Also present were Adrianne Guernon Deputy Borough Clerk, and George Botcheos solicitor, Leah Furhy Planner. Absent, Councilwoman Nucera.

**SALUTE TO THE FLAG**: Mayor Busch led in the salute to the flag.

**EXECUTIVE SESSION**: Continued talk about the possible purchase of the Brand Ave Mt Carmel property. This session continued from a pre 6:15 meeting.

Councilman Armbruster motioned to enter executive session at 7:00PM, seconded by Councilman Weaver and motion was carried upon the call of roll: Ayes: Armbruster, Weaver, Milano, Fisher, Andrews. Absent: Nucera. It was announced that it was anticipated that closed session would last approximately 30 minutes.

Councilman Weaver motioned to reenter open session at 7:35PM, seconded Councilman Armbruster and motion was carried upon the call of roll: Ayes: Fisher, Weaver, Armbruster, Milano, Andrews. Absent: Nucera.

#### **UNFINISHED BUSINESS:**

Councilwoman Andrews talked about the concerns of the Daniel Dougherty Field bathrooms that they were not cleaned and the trash was overflowing, Councilman Armbruster will speak with Public works to get that rectified. She also stated that Clean Communities was going to be held October 3 & 4th.

Mayor Busch went on to talk about the numerous phone calls he has received about the abandoned houses on Silver Lake Drive and how we can rectify the problem of the maintenance of the property. It was explained to him the procedures to follow up that it is not an easy process and steps have to be taken. He was notified that Al Sexton and Joann Watson are the people handling the foreclosed and abandoned properties and we are doing everything that the law allows to fix the problem.

#### **NEW BUSINESS:**

Request from friends of Clementon for use of small community center every 2nd Monday at 7:30PM it was unanimously agreed upon with council members.

Request for Amendment to mercantile license, hours of operation for La China Poblana

Request for equipment acquisition for OEM

A discussion entailed with Sheila Freiling being the Emergency Management Coordinator about the importance of her needing such equipment as a laptop and a cell phone to meet her deadlines, Councilman Armbruster elaborated that they will temporarily move the Council office which has a computer and they can't do anything about a cell phone till after November 1st Budget, since that office has used up the budget money for the year for training. Councilman Weaver will find out if there are any monies in any other line to purchase her a phone.

#### PRIVILEGE OF THE FLOOR:

Chris McKelvey Harwood Lane brought to councils attention that the streetlight on Atlantic Ave behind Produce Juntion at the curve has not been replaced since the storm, and he is concerned that it is awfully dark on that dangerous bend. He stated that the pole was replaced but the light was not, he was asked to get us a pole number and we would forward it to the Police Chief.

Keith Cybulski Van Horn Ave, wanted to know about the bill list for the open space. There was no bill list this meeting and he was advised by Councilman Weaver that it will be provided at the next meeting
