# MINUTES OF THE BOROUGH OF CLEMENTON OCTOBER 11, 2016 7:00PM SPECIAL MEETING OF THE MAYOR AND COUNCIL

OPENING: Mayor Thomas Weaver called the meeting to order at 7:04PM.

OPEN PUBLIC MEETINGS ACT ANNOUNCEMENT: Mayor Weaver read the following statement, "Pursuant to the provisions of the Open Public Meetings Act, Notice of this meeting has been posted at Borough Hall and transmitted to the Central Record and Courier post newspapers on October 6, 2016."

### NOMINATION TO FILL COUNCIL VACANCY:

Mayor Weaver stated that the Clementon Municipal Democrat Committee had submitted a letter containing the names of three nominees to fill the vacant term of Councilmember, expiring on December 31, 2016. Mayor Weaver announced that the nominees were John Hunter, Thomas Shaw and Anthony Nucera.

Councilwoman Nucera motioned to nominate Thomas Shaw to fill the unexpired term of Councilmember until December 31, 2016. Mayor Weaver asked if there were any other nominations. Hearing none, Councilman Fisher seconded the motion to nominate Thomas Shaw and motion was carried upon the call of roll. Ayes: Andrews; Fisher; Milano; Nucera. Absent: Armbruster.
