MINUTES OF THE BOROUGH OF CLEMENTON DECEMBER 15, 2015 CAUCUS/COUNCILMEETING OF THE MAYOR AND COUNCIL

OPENING: Mayor Fred Busch called the meeting to order at 7:03PM.

OPEN PUBLIC MEETINGS ACT ANNOUNCEMENT: Mayor Busch read the following announcement, "This meeting has been properly advertised and posted pursuant to N.J.S.A. 10:4-6, the Open Public Meetings Act."

ROLL CALL: Jenai Johnson, Municipal Clerk/Administrator, called the roll which resulted in the following members present: Mayor Fred Busch; Councilwoman Carol Andrews; Councilman Jonathan Fisher; Councilwoman Christine Nucera; Council President Thomas Weaver.

SALUTE TO THE FLAG: Mayor Busch led in the salute to the flag.

ENGINEER REPORT: Wayne Roorda of Bach Associates provided a written report, which has been filed in the appropriate manner, and verbally reported upon the following items: *Rehabilitation of Well NO. 9 (NJEIT)*- Mr. Roorda stated that his office had received a technical and administrative review letter from NJDEP dated July 17, 2015. Their office would be revising the plans and specifications for resubmission to NJDEP. Mr. Roorda noted that the project would possibly qualify for interim funding and noted he would consult with Parker McCay and Bowman, to discuss options for carrying thru until the next closing, scheduled for December of 2016.

Mohawk Avenue Storm Drain- Mayor Busch stated that he had previously brought up an issue with the dead end storm drain on Mohawk Avenue, and wanted to make the issue a priority prior to the spring rains. Mr. Roorda stated that he was aware of the issue, and would be attempting to speak to the County Engineer in reference to the matter and possible improvements.

Camden County Open Space Soccer Fields- Councilwoman Nucera stated that she was seeking the status of the soccer field project at Daniel Dougherty Sports Complex. Mr. Roorda stated that he was waiting to ascertain if other grant funds were available, and noted that they needed to make a decision on the layout of the fields, and necessity of the County providing access to a portion of the property. Mr. Roorda stated that it was his belief Councilman Armbruster was attempting to contact the County to discuss an easement onto county property.

Eyeglass Reimbursement Request-Jenai Johnson reported that a request had been received for reimbursement of eyeglasses from Richard Godin, a laborer in the public works department. Ms. Johnson noted that his glasses were damaged in the course of work and that reimbursement in the amount of \$358.40 was being requested. Councilman Weaver motioned to approve the eyeglass reimbursement, seconded by Councilwoman Andrews and motion was carried upon the call of roll. Ayes: Andrews; Fisher; Nucera; Weaver. Abandoned Properties- Mayor Busch stated that he had been working with the tax collector, chief of police, and code enforcement department to attempt to remedy the system with which the Borough deals with abandoned properties. Mayor Busch stated that it was his hope that the incoming Mayor would continue to work on this issue and reduce the number of abandoned properties within the Borough.

PRIVILEGE OF THE FLOOR:

Keith Cybulski, Clementon Borough- Mr. Cybulski stated that he wished to know where the old parking bumpers were. Mr. Cybulski also noted that he believed the Borough Governing Body was contradicting themselves and not thinking about the long term consequences relating to the change in Fire Department Line Officers.

Thomas Avellino, Clementon Borough- Mr. Avellino stated that he was a resident of town for 60 years, and noted his taxes had gone from \$4,000 to almost \$8,000. Mr. Avellino inquired why the Governing Body determined it necessary to purchase an artificial tree that cost \$5,000, when \$800.00 was previously spent on a live tree at Railroad Park. Councilman Weaver noted that there was never an intention to utilize the tree at Railroad Park as the Holiday Tree, due to safety concerns surrounding the tree lighting ceremony. Councilman Weaver also noted that it was his belief that the specs had been changed and the Borough had not purchased the \$800.00 live tree, to which Mr. Avellino referred.

Hearing no further comments, the floor was closed.
